MMTA Annual Business Meeting Minutes- June 14, 2022

Report of the Treasurer

Doug Rohde, NCTM Cash Management Plan

Our cash management plan as stated in the Policies, Fees and Payments document is to diversify funds as follows: Checking: A minimum of 15% of the annual budget Savings: Funds in excess of the above Reserve Funds/Investments: Maintain a reserve fund of at least 10% of the annual budget and work to create a reserve fund of 25% of the annual budget.

As of May 1, 2022, we are in compliance with the above guidelines.

Fiscal Year Notes

Shirley Holzer gift: We began tracking Vocal Young Artist expenses this year with the intent of using income from the investment of the Shirley Holzer gift to subsidize them. Registration income from Ensemble Festival, Music Bridges, MTNA Competitions, Piano Contest/Solo Festival, and Piano Education is down slightly. We are looking forward to these numbers increasing with certainty around in-person events. Program expenses were generally higher than the last two years, as events returned to being more in-person.

Logowear sales were good. We were almost sold out after the Piano Contest finals. Our t-shirt order was smaller than usual because we weren't certain how many in-person events we would be able to have. We didn't order new tote bags; instead we sold last year's "non-vintage" order out.

Budget Highlights

Fiscal year 2023 budget was approved at the May 12 board meeting. We approved a budget with a slight (~5%) deficit, with the intent of looking at ways to increase revenue and program participation to cover the deficit.

We changed our chart of accounts to streamline MMTA Foundation contributions, and monetary student awards, all into the same accounting area, rather than having the student awards showing as program expenses. We did this because monetary student awards are covered by the MMTA Foundation, not by program registrations.

This year the Diversity, Equity and Inclusion (DEI) committee partnered with the Indian Land Tenure Foundation (ILTF) to advocate for tribal communities in their efforts to acquire and consolidate treaty lands. Our partnership came in the form of a small donation, as well as a letter of support for legislative advocacy. The mission of MMTA is "advancing the profession of music", and we believe this includes efforts to ensure our Minnesota communities are healthy and vibrant. A representative of ILTF, David Garelick, is joining us for a panel discussion at the convention.

A number of MMTA DEI committee members were at the 2023 MTNA National Conference in Reno NV, and attended several sessions on DEI, including sessions on diverse repertoire by underrepresented composers, the MTNA DEI panel, and more.

We also spent some time this year reaching out to thought leaders in the DEI space locally. We made a connection with Roque Diaz, who heads up these efforts at MacPhail For Music. Dr. Diaz will also be on hand for the convention discussion, addressing the issue of "where do we go from here".

Judge Education Committee Jill Kilzer, NCTM, Chair

Mission Statement from the Endorsed Judge Handbook: The Judge Education Committee (JEC) oversees and supports the professional development of new and experienced judges and oversees all facets of the adjudication process for MMTA program events.

The JEC has trained 8 new judge candidates via Zoom this past year. More than half of the candidates have become Endorsed Judges.

The JEC met by Zoom several times through the program year to discuss recommendations for updates to the Endorsed Judge Handbook and to collaborate on a 2023 MMTA Convention Session: "A Birds-eye View of Judging: The Late Intermediate Student."

Virtual and in-person events continue as options for student participants and judges. Some judges prefer to judge only in-person; others prefer to judge virtual events only. Many are willing to judge either. Masking protocols are followed at all in-person events as appropriate.

MMTA Endorsed Judges are sent availability/sign up surveys each quarter of the program year. Judges are encouraged to sign up each quarter and for as many events as their schedule allows.

Annual Report, August 1, 2022 – July 31, 2023

The mission of the MMTA foundation is to improve the quality of music education in Minnesota by supporting the educational and charitable objectives of MMTA. To this end, the Foundation accepts tax-deductible contributions and solicits donations through fundraising events. This year, the Foundation fundraising campaign involved sending direct mail and e-mail requests for donations to members, as well as fundraising directly to membership at MMTA's annual convention. A QR code has been added to all publications originating from MMTA Foundation to facilitate more donations.

As of April 30, 2023, the MMTA Foundation had \$383,419 in its investment portfolio and in cash.

Year-to-date cash donations through April 30 total \$7,238, including \$3,836 donated for the establishment of the Patricia Langer Young Artist award. Many donations were made in honor of Merrily Stone, the 2023 MMTA Foundation Fellow.

Over \$20,000 were given to students for MMTA examination awards.

MusicLink Foundation

The MusicLink Foundation has had a great year of celebration as it recognizes 30 years of bringing quality music education to low-income children around the nation. Minnesota has contributed much to that success and Minnesota MusicLink continues to thrive with the valued support of MMTA.

The MusicLink Playathon returned this year after two years off due to Covid and it was great to hear all the in-person performances once again. Donations raised helped reimburse MusicLink teachers for expenses and helped with getting music to MusicLink students. Last summer 3 pianos were moved into student's homes—two of which were baby grands and recently a full size Clavinova was re-loaned to a new MusicLink student when the previous student graduated.

Currently, we have 58 active MusicLink teachers in Minnesota teaching 130 students. Summary

We are financially healthy in terms of our cash position, but we continue to face headwinds as we move forward. The cost of doing business is rising, but as an organization committed to providing access to all who want to participate, we tend to be extremely cautious when it comes to raising our prices in response.

Investments have been essentially flat for the last year or so but are well managed and a bit on the conservative side. We have not had to dip into our investments to pay the bills, but we are benefiting fairly significantly from the use of the gift from the Shirley Holzer estate to help cover the costs of vocal programs.

Our part-time bookkeeper, Pat Schroedl, retired in January after giving us excellent service and great value for many years. An extensive search for a replacement led us to bring this function in-house to save money -- the going rate for bookkeeping these days is at least twice what we had been paying Pat.

We did succeed this year in hiring a new accountant, Eric Stuber, CPA, whose rates are significantly lower than what we had been paying before. He is also providing guidance regarding bookkeeping and accounting practices as needed.

A note about the profit-loss report: this year we began moving toward booking income and expenses by "service date" – for example, all convention registration income will show up in the "month of June" column rather than when we received the check or credit card order, because the convention is in June.

This means that even though the report was generated on May 8, you will see some figures in the future – May, June, and July. This will be helpful in forecasting income and expenses through the end of the current fiscal year (July 31). Typically, we get income first (e.g. event registrations) and then the expenses come later (e.g. judge payment, rent.)

The biggest expenses yet to be realized for May, June and July are:

- Office rent
- Some insurance
- Payroll
- Convention expenses (mostly food and hotel fees)
- Honors Concert rent
- Piano Education program expenses for May and June
- Student awards

Cash Management Plan

Our cash management plan as stated in the Policies, Fees and Payments document is to diversify funds as follows: Checking: A minimum of 15% of the annual budget

Savings: Funds in excess of the above

Reserve Funds/Investments: Maintain a reserve fund of at least 10% of the annual budget and work to create a reserve fund of 25% of the

annual budget.

As of May 1, 2023, we are in compliance with the above guidelines.

Vice President of Finance Megan Gilles

The Vice-President of Finance oversees two areas within MMTA: human resources (employee relations) and finance (budgeting, financial oversight, policies, fees, and procedures).

I. Human Resources

We said goodbye to Sonja Gustafson after seventeen years of service. At this point we continue the hiring process and hope to have an Office Administrator as soon as possible. The Office Administrator will be assisting with bookkeeping/data entry with oversight from the Treasurer and our accountant.

Lorna Wolthoff completed one year of service to MMTA as the Office Assistant. She has been a wonderful addition to our office, has been learning quickly, and is eager to serve our organization and its members.

II. Finance

Prior to the 2022-2023, the finance committee and full board failed to create a balanced budget. A looming deficit continues to cause concern. This deficit is a result of decreased revenue (declining membership and fewer registrations for student events and convention), and steady or increased expenses (personnel expenses, office and site rent, cost of materials). In the first full year since Covid we have monitored the financial health of MMTA. In the next month, we will be proposing and hopefully accepting some difficult financial decisions to create better financial stability for MMTA. I hope that we can come to a consensus on a balanced budget. At the current rate of expenditure and income, we will face quite a deficit and will continue to pull from our savings which is unsustainable practice. We have a large expense looming with a needed website overhaul due to the aging coding language that our current website uses. Estimates have ranged from \$50,000-100,000. This large expense is in addition to the expenses that we face in a typical year of site and office rental and personnel expenses. We can not continue to add additional expenses while figuring out ways to greatly increase revenue. This becomes difficult to increase revenue as this relies on fewer student registrations and declining membership numbers. We need to move forward without adding larger amounts of expenses.

This past year, the finance committee has met at the minimum once a month. We have asked that all proposals that are financial in nature be presented to the finance committee prior to the full board so that we can investigate and provide a suggested path forward. The finance committee has also worked to update and clarify our Policies, Fees, and Procedures so that they are fully understood by those needing to implement them.

Thus, a negligible financial imposition on the homeowner could in the aggregate raise unprecedented capital to benefit Minnesota's Indian rural and urban communities.

MMTA as a [501(c)6] organization may engage in lobbying that is germane to <u>accomplishing its exempt purpose</u> without jeopardizing its exemption. Report of the President-Elect Laura Harding, NCTM

As I began my second year as President-Elect, my focus turned to the word connection. This involved connecting with members of the board of directors, program directors, local associations and members of the organization. Each of us brings something important to the table and my hope was to get to know our members even more this past year.

Here are some of the highlights during my second year as President-Elect:

- Connected monthly via email with program directors that report to the President-Elect
- Engaged in monthly staff meetings that include MMTA office staff and MMTA President
- Participated in monthly MMTA Finance Committee meetings
- Met monthly with the MMTA President
- Reached out and connected with a number of new MMTA members with in-person and zoom coffee chats
- Visited with all 12 local associations either in-person or with a member of the local association via Zoom.

Last September, I attended the MTNA Leadership Summit in Cincinnati, Ohio. This was the first Leadership Summit in person since 2019. We spent the weekend getting to know the MTNA Board of Directors, staff and leaders from other state associations. A highlight was networking in person while making connections that I have continued to foster throughout the year. MMTA is seen as a model association by many states. We have numerous programs for our students, an active membership base and a culture that sees the arts as important.

Additionally, in March, I attended my first ever MTNA Conference in Reno. I had a wonderful time connecting with colleagues, watching two MTNA Division winners compete at the national level and enjoyed dinner with members and leaders of the West Central Division. Congratulations to Adelina Mukhametzhanova, who placed 3rd in Senior Performance Voice. Her teacher is Melissa Holm-Johansen.

I am happy to report that Ensemble Festival participation was up by 17% over last year and composition contest/solo festival participation held steady. MTNA Competition and Music Bridges participation decreased over last year.

In an effort to better recognize our volunteers, I was able to bring a motion to the board of directors that gives our Volunteer of the Year both recognition at the Honors Concert and an all-inclusive MMTA Convention registration. I also worked to add the volunteer sign-up links to the emails that are sent to teachers when they receive their students' schedules. Many members volunteered at the MMTA Office this spring when we were short-staffed. I am grateful for their willingness to set up to help.

I would like to give a huge shout out to our MMTA office assistant, Lorna Wolthoff, for keeping the office running smoothly this spring. We are grateful for you! Thank you members, volunteers, site administrators, judges, teachers, and all for being flexible and adaptable.

Seeing that connections are a vital part of an organization, I will present a session at the MMTA Convention titled, "Threads of Human Connection". As I transition into the role of President, I intend to continue to focus on connections. It is what brings us all together.

This contest promotes creativity and practical application of music theory. Thirty-five young composers submitted original pieces in 2023 to the Original Composition Contest/Festival. Memorization in the Solo Festival is now optional, though performers who waive memorization will not be eligible for the highest rating. 1,679 students throughout the state registered to compete in the State Piano Contest Preliminaries in January 2023. 1,059 of these students, representing 240 teachers, were eligible for the Final Contest held at the University of Minnesota on March 4th and 5th. 1,057 students registered for the Final Contest and 1,037 actually competed. 162 students participated in the Piano Solo Festival.

A total of 516 winners were selected by 27 judges. The breakdown follows:

Even though the new and reinstating members continue joining MMTA for our programs, community, and professional development opportunities, the overall membership numbers continue to decrease (-2.43%), especially because of the retirement of the aging members and continued difficulties in recruiting younger members. As of May 1, 2023, there are 649 members (MMTA had 659 members as of May 1, 2022)

During July and August of 2022, I sent personalized emails to every member, answered their questions, and encouraged them to renew their membership. The Mentorship Committee under the stellar leadership of Kay Koehnen met over the summer to review the mentorship process and discussed the efficiency of our digital outreach efforts and a way to provide new and reinstated members with the hard copy of the MMTA materials. Kay diligently contacted and welcomed all new and reinstated members of MMTA and facilitated the process by which they could be set up with a mentor. She also kept a running log sheet with all the information about contacts (can be located on the shared Membership Drive). V&I Council has created an updated/adapted Virtual Submission Instruction document for V&I Exams. V&I encourages more virtual exams to promote additional participation and financial prudence :)

- 1. V&I has updated Voice testing materials and the voice syllabus. It will be finalized in the summer of 2023.
- 2. V&I Contests, Solo Festival, and Finale Concert will be held on April 6 or 13 2024 in Minneapolis. V&I will alternate Contest/Festival sites between St. Cloud and Minneapolis.
- 3. Voice Theory Exam will be renamed as 'Comprehensive Voice Exam'
- 4. Thank you to the Dr. Shirley Holzer Fund for enriching the voice program. The vocal program is growing because of it! Voice sessions at MMTA Convention are well represented due to the generous Dr. Shirley Holzer Fund.
- 5. A clarinet syllabus and testing materials are being developed. They are modeled after the flute materials.
- 6. String, Voice, woodwind, and Guitar participation at Contest, Festival and Young Artist Competition is becoming stronger. Thank you to Kevin Carlson who hosted this event at his church in St. Cloud, MN.
- 7. Lori Fiechtner McCauley is resigning from the Vocal & Instrumental (V&I) Vice President position 2023.
- 8. Thank you to the Vocal & Instrumental council for their hard work this year: Gene Swanson, Kevin Carlson, Katie Johnson, Melanie Hoffman-Katragadda, Dr. Jackie Lo, Laura Edman, Diane Jordan, and Kathy Larson.
- 9. 10. Modified Exam requirements for voice students to participate in contests is as follows: *
 - Age 13 and over are required to take Comprehensive Voice 1 or Piano Theory 1 to compete in MMTA Solo Contest
 - Junior Young Artist performers are required to take Comprehensive Voice 2 to compete
 - Senior & College Young Artist performers are required to take Comprehensive Voice 3 or college equivalent

VP Piano Education Mary Beth Millner, NCTM

The Education Committee reached out to the membership in December in a Member Survey, asking your opinions on direction for our Education programs. Directed by Susan Sophocleus, the results were summarized briefly, in the Weekly Updates, as well as a more thorough analysis on our website.

With that information, we are addressing concerns that were brought to our attention and are continuing both in-person as well as virtual exam opportunities.

I am pleased to report that the various committees under the umbrella of the Education Council are working together very cooperatively as we plan for future development of the programs with the 2030 revision as our goal. They are led by experienced dedicated personnel.

There will be an informative Convention Session presented by each of the Education committees. Thanks to a generous endowment from Shirley Holzer, we are also able to include some exciting vocal sessions at Convention.

The Piano Exam & Theory Exam Development Committees are working together to improve the alignment of these two programs, specifically with keyboard skills.

The Theory Exam Development Committee (under the leadership of Rebekah Richards) shared teaching tips through Theory Tuesday mini-sessions, which can be accessed on the website. They are in the process of revising the upper-level exams and will be revising those Student Handbooks.

Rebekah has put together some helpful Teacher Guidebooks (with Prerequisite Guidelines, Lesson Plans and games) for Levels 1, 2 & 3. They will be released at the 2023 Convention. A new online Theory exam will be available starting in the fall with the Artusi company.

The Piano Exam Development Committee (under the leadership of Jean Krinke & Grace Kopitske) has a timeline for the 2030 Syllabus Revision. They started with the keyboard skills and are now reviewing repertoire.

The Sight Playing Committee (under the leadership of Becky Nelson) is also hard at work on revisions to accompany the 2030 Syllabus revision. She is looking for additional members to join her committee. (Please reach out to Becky if you are interested.) Part of their focus is to have examples in keys & levels of difficulty appropriate to the levels.

I am very appreciative to the leaders of these committees for their dedication to providing quality programs to our students. At the same time, I must share that we absolutely need more volunteers to help at the exam sites so that the events run smoothly, and the results can be sent out in a reasonable amount of time. Please reach out to either Marcia Benson (Piano Exams) or Diane Shapiro (Theory Exams) if you (or possibly parents or high school students) can assist.

Since we all know that students do not get enough exposure to the arts in schools these days, our programs are that much more valuable. We are hard at work on the content of the exams, but Site Administrators have encountered some frustration with the lack of support from volunteers. Please give this some serious consideration, as we continue to encourage our students to

Piano Exam Development Committee Jean Krinke and Grace Kopitske, Chairs

The committee will have met 6 times throughout 2022-2023. Sara Langmead was the chair during the summer of 2022. Jean Krinke and Grace Kopitske assumed the position as co-chairs in October, replacing Sara Langmead.

- Long-term Planning for the 2030 Syllabus has begun.
- Keyboard Skills have been carefully reviewed with the goal of bringing Theory and Piano Exam skills and keys tested closer together. Once the revisions are complete and approved, Keyboard Skills Workbooks and testing materials for 2030 will begin.

- Corrections to keyboard skills tests have been made. Site administrators need to use revised testing material sent from the office rather than older tests which may be in their files.
- Repertoire review has begun, starting with the levels 10/11.
- Virtual Exams are being reviewed. In-person exams require a student to perform repertoire only once, on an unfamiliar instrument, and with an unfamiliar judge. Recommendations are in the process of being made to try to make virtual and in-person monetary award exams more equal. The new 2023 -24 Virtual Piano Exam recording guidelines for award levels (levels 4-11) will be in the newsletter and in the Handbook.
- The 2023 Convention session "Piano Syllabus for All" panel discussion will present ways for all teachers to use the Piano Syllabus. Besides being the main source for preparing students for piano exams, the Syllabus offers a wealth of information for all piano studios. The panel includes Jacob Fitzpatrick, Jo Ellen Kloehn, Grace Kopitske, Jean Krinke and Kay Koehnen.

The Theory Development Committee accomplished the following during 2022-23:

2. Completed the 2nd edition of Workbook 6. This is ready for publication and will be released in January 2024.

3. Neared the completion of the 2nd edition of Workbook 7. This will be ready for publication and release in January 2024.

4. Updated recordings on the MMTA website of the aural examples in Workbook 3, 2nd edition.

5. Created a Teacher Guide for Workbooks 1, 2, 3. These will be released at the June 2023 Convention.

6. Presented 3 sessions at the 2023 Convention:

- 1) Teaching Theory Levels 1 and 2 presenting the new Teacher Guidebooks. By Rebekah Richards
- 2) Trends in Music Theory

3) Fun with Analysis - What do all those accidentals mean? By Sarah Miller

7. Online Theory testing- an ad hoc committee (Marilyn Henry, Sue Krebsbach, Jill Kilzer, Sara Dietrich) worked with Artusi Company to design online exams for the written and aural portions of Level 1 and 2. These were beta tested in April.

8. Worked with the Piano Development Committee to find areas between the two programs that could be more closely aligned.

9. Theory exam for clarinet. Katie Johnson and Melanie Hoffman Katragadda considered creating a practical exam for clarinet which would replace the keyboard exam portion of the theory test. They determined the ordering of theory

concepts for clarinet students is different enough from piano students that they needed to create a theory test specific to clarinet. They are working with the Vocal and Instrumental Programs Committee to create a clarinet exam based on the current flute exams.
